# 1. Welcome

The meeting began at 1 pm and was declared quorate by Carol Monaghan MP. Carol began the meeting by explaining her interest in ME and the aim of the new APPG to produce a report paper on key issues impacting ME sufferers.

The purpose of this inaugural meeting was to elect new officers and register the APPG.

# 2. Election of Officers

Six Officers were nominated to roles within the APPG: Chair (named contact): Carol Monaghan MP (SNP) Co-Chair: Stephen Metcalfe MP (Con) Co-Chair: Sharon Hodgson MP (Lab) Treasurer: Olivia Blake MP (Lab) Secretary: Hywel Williams MP (Plaid) Vice Chair: Ben Lake MP All Officers were elected.

# 3. AOB and Close

Carol Monaghan MP notified APPG members that the next meetings have been provisionally booked for the 11<sup>th</sup> February 2020 and 10<sup>th</sup> March 2020.

The proposed future meeting topics were then discussed briefly:

- 1. Access to healthcare as GET/CBT has proven ineffective
- 2. Access to financial support and welfare benefits e.g. Personal Independence Payment
- 3. Protection for children with ME
- 4. Biomedical research spending by the Medical Research Council (MRC) and National Institute

These were agreed upon with an addition of topics: (1) economic and societal impact of ME as a justification for additional spending (which was suggested by Stephen Metcalfe MP), and (2) medical diagnosis (which was suggested by Olivia Blake MP).

The Secretariat, Charles Shepherd from ME Association, then answered some questions on biomedical research updates.
